


year, with limited employees at the offices and no in-person meetings. Lake Region managed to handle most of the co-op business with Zoom conference calling software and social distancing.





# Home EV Charging Station Rebate Available

Lake Region looks forward to helping members interested in an EV home charger. To encourage efficient EV battery management strategies, we are now offering a \$250 rebate for a new Level 2 Energy Star electric vehicle chargers installed at member's homes.

A Level 2 charger requires 240-volts, the same voltage used by an electric clothes dryer. This charges your vehicle faster than a Level 1 charger, which uses a standard 120-volt three-prong outlet charger. A variety of Level 2 chargers are available *1801101* from different manufacturers and should be selected to match your vehicle.

**Step 1:** Print off the EV Charger Rebate form from our website **www.lrecok.coop/rebates** 




**Step 2:** Find a state licensed and bonded electrical contractor to install your charger.
